VERIFIED CLAIM FOR STATUTORY LIEN

The Plaintiff, City of Chicago, a Municipal Corporation, by virtue of the authority granted by Chapter 114, Section 11-1201.4 of the Illinois General Statutes and by Chapters 125 and 125.1 of the Municipal Code of the City of Chicago files this claim for Statutory Lien against the following premises commonly known as: 1220 N. NOBLE, CHICAGO, IL, and briefly described as:

I, James R. Johnston, Jr., Director of Water Services, being first duly sworn on oath and after examining the records of the City of Chicago Department of Water, dover and staton in support of this claim, follow:

- 1) That water service was furnished to herein described property by the Claimant, at the rate as provided by Chapter 125 of the Municipal Code of the City of Chicago.
- 2) That the quantity of water was approximately 142 thousand cubic feet.
- 3) That the amount due for water service is \$1803.75.
- 4) That water service was furnished to the herein described property by the Claimant, at the rate as provided by Chapter 125.1 of the Municipal Code of the City of Chicago.
- 5) That the amount due for water service is \$799.41.
- 6) That the total amount due the Claimant therefore is \$1803.75.
- 7) That the above amounts became delinquent on JUNE 23, 1990.
- 8) That notice of the filing of this claim for Lien was mailed to "owner or owners and party or parties interested in the premises" located at 1220 N. NOBLE, CHICAGO, IL 60622 on JULY 23, 1990, and the amount claimed herein represents both the indebtedness due as of the notice date, and any subsequent amounts which may have accrued.
- 9) That as of this date said owner, titleholders or parties are not entitled to any credits or account; leaving due, unpaid, and owing to the Claimant the amount claimed herein.

WHEREFORE, the Claimant, City of Chicago, a Municipal Corporation claims a lien against the herein described property in the amount of \$1803.75, with statutory interest from this date.
