- 3. A corporation cannot act as its own registered agent.
- If the registered office is changed from one county to another, then the corporation must file with the recorder of deeds of the new county a certified copy of the articles of incorporation and a certified copy of the statement of change of registered office. Such certified copies may be obtained ONLY from the Sicritary of State.
- Any change of registered event must be by resolution adopted by the board of directors. This state-- 5. ment must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
 - The registered agent may report a change of the registered office of the corporation for which he or she is registered agent. When the (got) reports such a change, this statement must be signed by County Clerk's Offic the registered agent.


