There is now justly due and owing to Claimant, after allowing to the Owners and Contractor all credits, deductions and set-offs, \$99,304.00 which is still due and unpaid, plus interest. Claimant now claims a lien on the above-described property and all improvements on it, against the Owners and all persons interested, and also claims a lien on any attounts due from the Owners to Contractor for \$99,304.00, together with interest, according to the statute.
