- 2) That the quantity of water was approximately 330 thousand cubic feet.
- 3) That the amount due for water service is \$2304.99.
- 4) That sewer service was furnished to the herein described property by the Claimant, at the rate as provided by Chapter 165.1 of the Municipal Code of the City of Chicago.
- 5) That the amount due for sewer service is \$1797.90.
- 6) That the total amount due the Claimant therefore is \$4102.89.
- 7) That the above amounts became delinquent on JUNE 25, 1990.
