MODIFICATION AGREEMENT FOR MOME EQUITY CREDIT LINE

This Modification Agreement dated <u>Oct. 1, 1990</u> by and between American National Bank and Trust Company of Chicago ("Bank") and <u>John J. Phelan & Karen D. Phelan</u> ("Borrower") concerning the Borrower's home equity credit line with the Bank.

WHEREAS, Borrower and Bank have agreed to would'y the terms and conditions of the Home Equity Credit Line Agreement, Promissory Hote and Mortgage.

WHEREAS Borrower warrants and represents to Bank thet there are not other sortgages or any subsequent liens now outstanding against the mortgaged premises other than the First Mortgage held by EIRST CHGO, BANK OF OAK PARK and that the lien created by the home equity credit line, as modified herein is a valid Second Mortgage lien on the mortgaged premises previously described.

NOW THEREFORE for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, it is hereby agreed by and between the parties that the terms of the note are modified as follows:

1) <u>Credit Limit</u> - The limit on the home equity credit line is hereby increased to \$100,000.00 , which the undersigned Borrover agrees not to exceed.

- 2) Borrover hereby agrees to pay the Bank a fee for procurement of a title report showing any and all recorded liens against the mortgaged premises.
- 3) Notwithstanding anything to the contrary herein, the terms and conditions of the aforementioned note and Home Equity Credit Line Agreement, not expressly modified by the terms of this modifications, shall remain in full force and effect. In all other respects, the borrower reaffirms all of the terms, conditions, and covenants of the Note and Agreement as identified above. In addition, this Modification meither changes, modifies, extends, establishes nor terminates any rights or obligations of the parties to any of the mortgage loan documents presently encurarying the mortgaged premises or any modifications thereof.

In consideration of the modification of the terms of the Home Equity Credit Line Agreement and Note, as here and above set forth, borrower hereby covenants and agrees to pay the balance of the indebtedness evidenced by the Mote and secured by the mortgage as herein modified, and to perform the covenants contained in the mortgage and further agrees that the prepayment privilege now in effect shall remain in full force and in effect.
