7. Protection of Our Rights in the Property; Mortgage Insurance. We shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify amortization. of the sums secured by this Mortgage by reason of any demand made by the original Account Holder's successors in interest. Any forebearance by us in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy.

9. Successor and Assigns Bound; Joint and Several Liability; Co-Signers. The covenants and agreements of this Mortgage shall bind and benefit the successors and assigns of you and us, subject to the provisions of paragraph 12.
