and Far East Construction Company, Inc., was owner's contractor for the improvement therof.

That on 10 May, 1990, said contractor made a subcontract with the claimant to furnish and install four (4) steel overhead garage doors with related appurtenances

for and in said improvement, and that on 18 Jun, 1990, the claimant completed thereunder all required by said contract to be done

That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$ none and completed same on 19 90

That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) do not reside in said County.

That said contractor is entitled to credits on account thereof as follows:  
payment on account in the amount of \$1,500.00

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of Two Thousand five hundred fifty two and No/100ths (\$2,552.00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

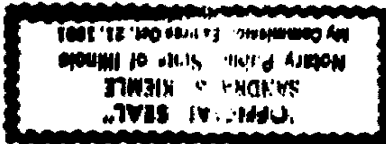
