ANNEXATION OF LOT 10 IN BLOCK 2

(13611 Le Claire Avenue)

Pursuant to Section 7-1-13 of the Illinois Municipal Code, providing for the annexation of unincorporated territory, containing 60 acres or less, wholly bounded by the Village of Crestwood;

A petition requesting such annexation having been filed with the Village by Robert Daunt, 13611 Le Claire Avenue, as one of the owners of the subject property, as described herein;

The Village Board having passed, approved, and enacted, on September 6, 1990 "An Ordinance Providing for the Publication of Legal Notice that the Annexation of Lot 10 in Block 2 in Midlothian Fields Subdivision is Contemplated"; and

Section One: Notice has been given, as provided by law, that the annexation of the following described territory is contemplated by the Corporate Authorities of the Village of Crestwood, pursuant to Section 7-1-13 of the Illinois Municipal Code, being a lot approximately 108 feet by 188 feet and wholly bounded by the Village of Crestwood:

Lot Ten (10) in Block 2 in Midlothian Fields, being a Subdivision of the West Half (W 1/2) of the Northeast Quarter (NE 1/4) of Section 4, Township 36 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

Section Two: The described territory is wholly bounded by the Village of Crestwood.

Section Five: The Village Clerk shall file a plat of annexation describing said property, together with a duly certified copy of this Ordinance, in the office of the Recorder of Cook County, Illinois.

Section Six: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

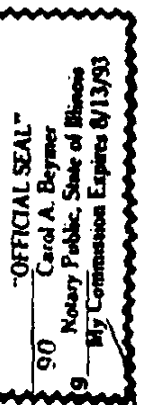
