ORDINANCE NO. 0A-24-90

AN ORDINANCE AMENDING ORDINANCE NO. 0-5-90
TO CORRECT ERRORS IN THE LEGAL DESCRIPTION
OF THE SUBJECT PROPERTY THEREOF

WHEREAS, on February 12, 1990, the City Council enacted its Ordinance No. 0-5-90 "An Ordinance Annexing Certain Property to the City of Country Club Hills (Frances House)"; and

WHEREAS, the plat of annexation which was furnished to the City contains certain inaccuracies in the legal description of the subject property thereof; and

WHEREAS, the owner of the subject property has requested that an amendatory ordinance be enacted to correct said errors in the legal description;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COUNTRY CLUB HILLS, COOK COUNTY, ILLINOIS, as follows:

SECTION 1: Ordinance No. 0-5-90 is hereby amended by substituting the following legal description for the subject property:

Lot #7 in Homewood Estates being a Subdivision of the Southeast 1/4 of the Southeast 1/4 (except the South 520 feet of the East 520 feet and except the North 165 feet thereof) of Section 33, Township 36 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois.

Lot #6 in Homewood Estates being a Subdivision of the Southeast 1/4 of the Southeast 1/4 (except the South 520 feet of the East 520 feet and except the North 165 feet thereof) of Section 33, Township 36 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval, and shall subsequently be published in pamphlet form as provided by law.
