## ORDINANCE NO. 0A-24-90

AN ORDINANCE AMENDING ORDINANCE NO. 0-5-90 TO CORRECT ERRORS IN THE LEGAL DESCRIPTION OF THE SUBJECT PROPERTY THEREOF

WHEREAS, on February 12, 1990, the City Council enacted its Ordinance No. 0-5-90 "An Ordinance Annexing Certain Property to the City of Country Club Hills (Frances House)"; and

WHEREAS, the plat of annexation which was furnished to the City contains certain inaccuracies in the legal description of the subject property thereof; and

WHEREAS, the owner of the subject property has requested that an amendatory ordinance be enacted to correct said errors in the legal description;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COUNTRY CLUB HILLS, COOK COUNTY, IJLINOIS, as follows:

SECTION 1: Ordinance No. 0-5-90 is nereby amended by substituting the following legal description for the subject property:
