- 3. The maturity date of the Note and Second Mortgage is hereby changed to October 2, 2010.

- 4. Payments shall be due monthly beginning 11/20/90, and on the same day of each month thereafter, consisting of principal and interest payments of FOUR HUNDRED AND NO/100 DOLLARS (\$400.00) with interest paid in arrears on the pricipal balance outstanding from time to time.
- 5. That commencing on 10/2/90, interest shall be computed at a rate per annum equal to nine and one-quarter percent (9.25%). Interest on the unpaid balance thereof shall be computed from the date hereof on a 365 day year basis, for the actual number of days elapsed.
- 6. Except for the modifications stated hereinabove, the Note and Second Mortgage are not otherwise changed, modified or amended.
