That on September 1, 1989, the claimant made a contract with MITROFF COMPANIES, authorized or knowingly permitted by NBD TRUST COMPANY OF ILLINOIS, TRUSTEE, TRUST NO. 4063-AH, to make said contract, or in the alternative and upon information and belief, MITROFF COMPANIES is a beneficiary of the aforesaid land trust to furnish landscaping materials and labor for the sales office and associated parking area being erected on said land for the sum of \$28,310.00 and on May 24, 1990, completed thereunder all required by said contract to be done.

That at the special instance and request of said owner, the claimant furnished extra and additional materials and extra and additional labor for said premises to the value of \$7,443.00 and completed same on May 24, 1990.

That said owner is entitled to credits on account thereof as follows, to wit: Thirty-Three Thousand Seven Hundred Forty Three and 70/100 Dollars (\$33,743.70), leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of Two Thousand Dollars (\$2,000.00), for which, with interest, the claimant claims a lien on said land and improvements.

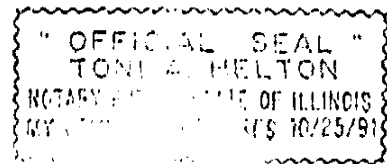
