

TRUST DEED

THIS INDENTURE, made this 1st day of March, 1962, between

herein referred to as "Grantors", and [Name] of [County], Illinois,

herein referred to as "Trustee", witnesseth:

THAT, WHEREAS the Grantors have promised to pay to Associates Finance, Inc. herein referred to as "Beneficiary", the legal holder of the Loan Agreement hereinafter described, the sum of [Amount] Dollars (\$ [Amount]), evidenced by one certain Loan Agreement of the Grantors of even date herewith, made payable to the Beneficiary, and delivered, in and by which said Loan Agreement the Grantors promise to pay the said sum in consecutive monthly installments: at \$ [Amount] followed by [Amount] at \$ [Amount] followed by [Amount] at \$ [Amount] with the first installment beginning on [Date] (Month & Day)

and the remaining installments continuing on the same day of each month thereafter until fully paid. All of said payments being made payable at [Address], Illinois, or at such place as the Beneficiary or other holder may, from time to time, in writing appoint.

NOW, THEREFORE, the Grantors to secure the payment of the said obligation in accordance with the terms, provisions and limitations of this Trust Deed, and the performance of the covenants and agreements herein contained, by the Grantors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do hereby present CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate (with all their estate, right, title and interest therein) situated, lying and being in the County of [County] AND STATE OF ILLINOIS, to wit:

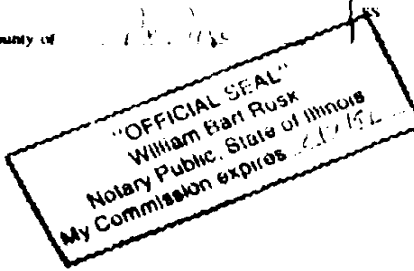

This Trust Deed consists of two pages. The covenants, conditions and provisions appearing on page 2 (the reverse side of this trust deed) are incorporated herein by reference and are a part hereof and shall be binding on the Grantors, their heirs, successors and assigns.
