AND NOW THEREFORE, it is agreed that the Note, or other obligation, evidencing said mortgage indebtedness, shall be and it is hereby modified to provide, that the amount of indebtedness be increased to Two Hundred Twenty Five Thousand Dollars (\$225,000.00)-----

In all other respects said Note, or other obligation, and said mortgage shall remain unchanged and be in full force and effect.

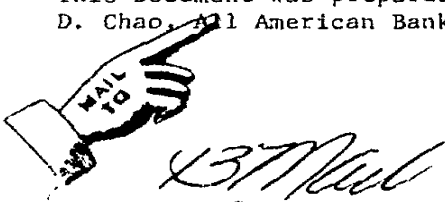
