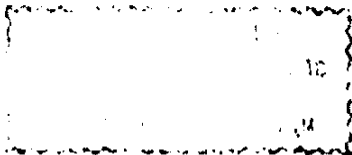

## EXHIBIT "A"

### PARCEL 1:
