THIS INDENTURE, made **MAY 11, 1990** between
HERNKYUNG KIM and **EUNHEE KIM**, his wife

herein referred to as "Mortgagors", and **CHICAGO TITLE AND TRUST COMPANY**, an Illinois corporation doing business in Chicago, Illinois, herein referred to as **TRUSTEE**, witnesseth

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the principal Promissory Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the Principal Sum of

and delivered, in and by which said Principal Note the Mortgagors promise to pay the said principal sum on **DEMAND** with interest on the principal balance until maturity at the rate of prime plus 2 per cent per annum, payable monthly on the 20th day of each month in each year, all of said principal and interest bearing interest after maturity at the rate of prime plus 7 per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in **Chicago**, Illinois, as the holders of the note may, from time to time, in writing appoint and in absence of such appointment, then at the office of **MAYFAIR BANK** at **4001 W. Devon, Chicago, Illinois 60646**.

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situated and being in the **Village of Mt. 


