RESOLUTION NO. 11244

AN ORDINANCE TO AMEND THE CHARTER OF THE COUNTY OF COOK, ILLINOIS, BY CHANGING THE NAME OF THE COUNTY CLERK TO THE COUNTY CLERK OF COOK COUNTY, ILLINOIS, AND TO REPEAL ALL OTHER LAWS IN CONFLICT HEREWITH.

WHEREAS, the Charter of the County of Cook, Illinois, as amended, provides for the election of a County Clerk, and the County Clerk is the chief executive officer of the County; and

WHEREAS, it is the desire of the Board of Supervisors to amend the Charter of the County of Cook, Illinois, by changing the name of the County Clerk to the County Clerk of Cook County, Illinois, and to repeal all other laws in conflict herewith;

BEFORE ENACTING THIS ORDINANCE, NOTICE WAS GIVEN TO THE PUBLIC BY PUBLICATION IN A NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY OF COOK, ILLINOIS, OF THE TIME AND PLACE WHEREIN SAID BOARD OF SUPERVISORS WOULD HOLD A PUBLIC HEARING ON SAID ORDINANCE, AND A PUBLIC HEARING WAS HELD AT SAID TIME AND PLACE, AND THE PUBLIC WAS HEARD;

AND WHEREAS, the Board of Supervisors, after due deliberation, has adopted this Ordinance;

IT IS THE ORDER OF THE BOARD OF SUPERVISORS OF SAID COUNTY OF COOK, ILLINOIS, THAT THE CHARTER OF SAID COUNTY OF COOK, ILLINOIS, BE AMENDED BY CHANGING THE NAME OF THE COUNTY CLERK TO THE COUNTY CLERK OF COOK COUNTY, ILLINOIS, AND THAT ALL OTHER LAWS IN CONFLICT HEREWITH BE REPEALED.

ENACTED AND PASSED AT A REGULAR MEETING OF THE BOARD OF SUPERVISORS OF SAID COUNTY OF COOK, ILLINOIS, HELD AT CHICAGO, ILLINOIS, ON THE 12TH DAY OF JANUARY, 1991.
