THIS INDENTURE made OCTOBER 30 19 90, between RAYMOND D. ANDERSON & VIRGINIA ANDERSON, HIS WIFE, herein referred to as "Mortgagor", and

an Illinois corporation doing business in C.C. HILLS, Illinois, herein referred to as Trustee, witnesseth: THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the installment Note herein after described, said legal holder or holders being herein referred to as Holders of this Note, in the principal sum of FIVE THOUSAND AND 00/100 (\$5,000.00) Dollars, evidenced by one certain Installment Note of the Mortgagors of even date herewith, made payable to 1st HERITAGE BANK

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest on the balance of principal remaining from time to time unpaid at the rate of 12.00 per cent per annum in installments as follows:

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each installment unless paid when due shall bear interest at the rate of maximum allowed by law per annum, and all of said principal and interest being made payable at such banking house or trust company in C.C. HILLS Illinois as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of 1st HERITAGE BANK in said City of COUNTRY CLUB HILLS, IL.
