

ORDINANCE NO. 1990 - 43

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF STREAMWOOD, COOK COUNTY, ILLINOIS KNOWN AS THE DENTON PROPERTY

whereas, a written petition signed by the legal owners and electors of record of all the land within the territory herein described has been filed with the Vinlige Clerk of the village of Streamwood, Cook County, Illinois, requesting that and territory be annexed to the Village of Streamwood; and

whereas, the territory is not within the corporate limits of any municipality but is consiquous to the Village of Streamwood; and

whereas, legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State Statute; and

WHEREAS, the affidavit of service of such notices required herein is on deposit with the Village Clerk and shall be recorded in the office of the Recorder of Deeds of Cook County, Illinois; and

whereas, the legal owners of record of said terricory and the Village of Streamwood have entered into a valid and binding annexation agreement relating to such territory; and

whereas, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of said annexation agreement and with the Statutes of the State of Illinois, specifically Chapter 24, Paragraph 7-1-8, Illinois Revised Statutes: and

WHEREAS, it is in the best interest of the Village of Streamwood that said territory be annexed thereto.

NOW, THEREFORE. BE IT ORDAINED by the President and Board of Trustees of the Village of Streamwood, Cook County, Illinois as follows:

SECTION ONE: That the property legally described in Exhibit "A" attached hereto being indicated on an accurate map of the annexed territory (which is appended to and made a part of this ordinance) is hereby annexed to the Village of Streamwood, Cook County, Illinois.

SECTION TWO: That the Village Clerk is hereby directed to record with the Recorder of deeds and to file with the County Clerk, a certified copy of this ordinance, together with the accurate map of the territory annexed appended to this Ordinance.

SECTION THREE: That all ordinances and resolutions or parts thereof in conflict with the provisions or this ordinance are, to the extent of such conflict, expressly repealed.

SECTION FOUR: That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
