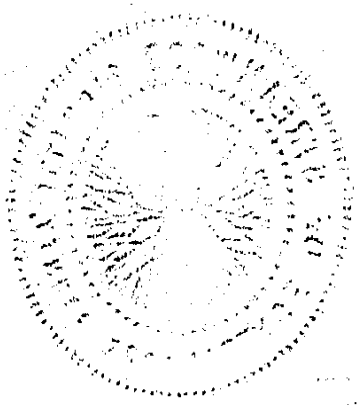

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE

**WHEREAS,** a written petition signed by the legal owners and electors of record of all the land within the territory herein described has been filed with the Village Clerk of the village of Streamwood, Cook County, Illinois, requesting that said territory be annexed to the Village of Streamwood; and

**WHEREAS,** the territory is not within the corporate limits of any municipality but is contiguous to the Village of Streamwood; and

**WHEREAS,** legal notices regarding the intention of the Village to annex said territory have been sent to all public bodies required to receive such notice by State Statute; and

**WHEREAS,** the affidavit of service of such notices required herein is on deposit with the Village Clerk and shall be recorded in the office of the Recorder of Deeds of Cook County, Illinois; and

**WHEREAS,** the legal owners of record of said territory and the Village of Streamwood have entered into a valid and binding annexation agreement relating to such territory; and

**WHEREAS,** all petitions, documents, and other necessary legal requirements are in full compliance with the terms of said annexation agreement and with the Statutes of the State of Illinois, specifically Chapter 24, Paragraph 7-1-8, Illinois Revised Statutes; and

**WHEREAS,** it is in the best interest of the Village of Streamwood that said territory be annexed thereto.


