REPUBLIC SAVINGS BANK, F. S. B. LOAN MODIFICATION AGREEMENT TO EXTEND MATURITY DATE

This Modification Agreement is dated as of the 1st day of August, 1990 and is made between Chicago Title and Trust Company, not personally, but as Trustee, under Trust Agreement dated 7/28/89 and known as Trust No. 1093370 ("Borrower") and REPUBLIC SAV-INGS BANK, F. S. B., 4600 West Lincoln Highway, Matteson, IL 60443, its successors and/or assigns ("Lender").

#### UNDERSTANDINGS

- Borrower executed a Mortgage in favor of Lender dated as of August 17, 1989 and registered September 5, 1989 with the Cook County Registrar of Titles as Document No. 3822493 (the "Mortgage") and recorded September 13, 1989 with the Cook County Recorder of Dords as Document No. 89429597 (the "Mortgage") and re-recorded 11 10 as Document No. (1) 11110 . encumbering the real estate on Exhibit A attached hereto and made a part hereof.
- B. The Mortgage secures the indebtedness, obligations and liabilities of Borrover pursuant to a Promissory Note in the original principal amount of \$112,000.00, dated August 17, 1980, payable to Lender and explated by Borrower ("Note").
- C. The principal balance of the Note is due and payable on August 1, 1990 ("Maturity Date"). As of the Maturity Date, the outstanding principal balance one is \$112,000.00.
- D. The accrued and unpaid interest on the outstanding principal balance of the Note as of this Modification Agreement date is \$1,253.78.
- E. Borrower wished to extend the Maturity Date of the Note and Mortgage Lender is willing to do so.
- NOW, THEREFORE, in consideration of the Understandings set forth above, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Borrower and Lender agree as follows:
- 1. The Maturity Date of August 1, 1990, as set forth in the Note and Mortgage is hereby deleted and the following inserted in lieu thereof:

### August 1, 1991

In all other respects, the terms and provisions of the Note and Mortgage shall remain unchanged and in full force and effect.
