

AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP FOR 805-807 W. WOLFRAM CONDOMINIUM

This Amendment is made by the persons who executed the consents to this Amendment which are attached hereto ("Consenting Owners").

The Declaration of Condominium Ownership for 805-807 W. Wolfram Condominium was made by LaSalle National Bank, not individually, but as Trustee under Trust Agreement dated April 26, 1982 and known as Trust No. 10-39858-09 and recorded in Cook County, Illinois, August 12, 1987 as Document No. 87445679. The Consenting Owners are the owners of the Dwelling Units of 805-807 W. Wolfram Condominium.

The owner of Units 7 and 8 of 805-807 W. Wolfram Condominium, which Units are contiguous to each other, wishes to alter the boundaries of there Units by including a room and bathroom on the second floor of Unit 7 as part of the second floor of Unit 8.

The Consenting Owners consent to this alteration. The Consenting Owners, therefore, desire to amend Exhibits C and D to the Declaration to reflect the change in the boundaries of the two condominium Units and to the consequent change in the undivided interest of each Dwelling Unit in the Common Elements.
