NOTICE OF WEED LIEN

The claimant, THE VILLAGE OF HOFFMAN ESTATES, a municipal corporation of the Village of Hoffman Estates, Cook and Kane Counties, and State of Illinois, hereby files a claim for lien against the owner of the property known as vacant parcel Hoffman Estates, Illinois, pursuant to Illinois Revised Statutes Chapter 24, Sections 11-206 and 11-20-7.

That the property above is in the County of Cook, State of Illinois, and legally described as follows:

THE SOUTH 200 FEET, AN HEAVENED ALONG THE EAST AND WEST LINES THEREOF, OF THE FOLLOWING DESCRIBED PROPERTY: BEGINNING AT THE INTERSECTION OF THE CENTER LINE OF HIGGINS ROAD WITH THE EAST LINE OF SECTION 16, TOWNSHIP 41 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN SAID POINT BEING 512.85 FEET SOUTH OF THE NORTHEAST CORNER OF SAID SECTION 16; THENCE SOUTH ON THE EAST LINE OF SAID SECTION 16, 618.42 FEET THENCE WESTERLY ON A LINE PARALLEL WITH THE NORTH LINE OF SAID SECTION 16, 700 FEET TO A POINT; THENCE NORTH ON A LINE PARALLEL WITH SAID EAST LINE OF SECTION 16, 490.44 FEET TO THE CENTER LINE OF HIGGINS ROAD 208.80 FEET TO THE POINT TO BEGINNING (EXCEPT THEREFOR THAT PART HERETOFORE DEDICATED TO THE STATE OF ILLINOIS FOR HIGHWAY PURPOSES BY DRED, DOCUMENT NUMBER 12284907 IN COOK COUNTY, ILLINOIS).

That upon the date of May 14, 1990, \$50.00 was expended to provide for the destruction of weeds upon the above named premises by the Village of Hoffman Estates, Illinois

That there is still due, unpaid and owing to the claimant, the balance of \$100.00 for which, with interest, the claimant claims a lien on said land and improvements. \$50.00 plus \$50.00 administrative fee
