That the property above is in the County of Cook, State of Illinois, and legally described as follows:

THE SOUTH 200 FEET, AS MEASURED ALONG THE EAST AND WEST LINES THEREOF, OF THE FOLLOWING DESCRIBED PROPERTY: BEGINNING AT THE INTERSECTION OF THE CENTER LINE OF HIGGINS ROAD WITH THE EAST LINE OF SECTION 16, TOWNSHIP 41 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN SAID POINT BEING 512.65 FEET SOUTH OF THE NORTHEAST CORNER OF SAID SECTION 16; THENCE SOUTH ON THE EAST LINE OF SAID SECTION 16, 618.42 FEET THENCE WESTERLY ON A LINE PARALLEL WITH THE NORTH LINE OF SAID SECTION 16, 200 FEET TO A POINT; THENCE NORTH ON A LINE PARALLEL WITH SAID EAST LINE OF SECTION 16, 690.44 FEET TO THE CENTER LINE OF HIGGINS ROAD 208.80 FEET TO THE POINT TO BEGINNING (EXCEPT THEREFORM THAT PART HERETOFORE DEDICATED TO THE STATE OF ILLINOIS FOR HIGHWAY PURPOSES BY DEED, DOCUMENT NUMBER 12284907 IN COOK COUNTY, ILLINOIS.
