herein referred to as "Trustee," witnesseth: That Whereas Mortgagors are justly indebted to the legal holder of a principal promissory note, termed "Installment Note," of even date herewith, executed by Mortgagors, made payable to Trustee and delivered in and by which note Mortgagors promise to pay the principal sum of THREE THOUSAND FIVE HUNDRED NINETY-SEVEN AND NINETY SIX CENT Dollars, and interest from OCTOBER 15, 1990 on the balance of principal remaining from time to time, provided at the rate of 49.02 per annum, such principal sum and interest to be payable in installments as follows: TWO HUNDRED NINETY-NINE AND EIGHTY-THREE Dollars on the 15 day of OCTOBER, 19 90 and TWO HUNDRED NINETY-NINE AND EIGHTY-THREE CENTS Dollars on the 15 day of each and every month thereafter until said note is fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due on the 15 day of SEPTEMBER, 19 90, all such payments on account of the indebtedness evidenced by said note to be applied first to accrued and unpaid interest on the unpaid principal balance and the remainder to principal; the portion of each of said installments constituting principal, to the extent not paid when due, to bear interest after the date for payment thereof, at the rate of 49.02 per cent per annum, and all such payments being made payable at MERCURY FINANCE COMPANY or at such other place as the legal holder of the note may, from time to time, in writing appoint, which note further provides that at the election of the legal holder thereof and without notice, the principal sum remaining unpaid thereon, together with accrued interest thereon, shall become at once due and payable, at the place of payment aforesaid, in case default shall occur in the payment, when due, of any installment of principal or interest in accordance with the terms thereof or in case default shall occur and continue for three days in the performance of any other agreement contained in this Trust Deed (in which event election may be made at any time after the expiration of said three days, without notice), and that all parties thereto severally waive presentment for payment, notice of dishonor, protest and notice of protest.

NOW THEREFORE, to secure the payment of the said principal sum of money and interest in accordance with the terms, provisions and limitations of the above mentioned note and of this Trust Deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, Mortgagors by these presents CONVEY AND WARRANT unto the Trustee, its or his successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the TOWN OF HILLSIDE COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

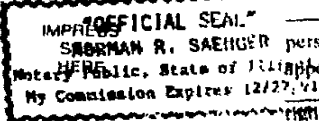
