KNOW ALL MEN BY THESE PRESENTS, that I, ROGER A. WOOD, do by these presents, hereby name, designate and appoint DERENDA COLLINS, to serve as my true and lawful attorney-in-fact, with full power and authority to do and perform any and all acts which she, in her unlimited discretion, deem if necessary, desirable and beneficial to me, with reference to all of my personal and business affairs, as well as all the real and personal property now owned by me.

In executing this instrument, it is my intention to give DERENDA COLLINS the full and unlimited discretionary power and authority to endorse and issue checks, to pay my bills, to collect and receive funds due to me, to sue or file warrants in my name, to execute Contracts, Notes, Trust Deeds and other evidences of indebtedness and to sell and convey such portions of my real or personal property as may be necessary, and to do any other act desirable or beneficial to me in taking care of my personal and business affairs.

I also, as principle under this executed Durable Power of Attorney, do hereby request and nominate DORENDA COLLINS to serve as Conservator, Guardian of my Estate, or Guardian of my person for consideration by the Court if protective proceeding for my person or estate are hereafter commenced.

In executing this instrument, it is my intention that this instrument operate as a Durable Blanket Power of Attorney so that my attorney-in-fact is empowered to exercise all of the above powers and this Power of Attorney shall not be affected by subsequent disability or incapacity of the principle, in the event I should become physically or mentally incapable of performing such duties personally.

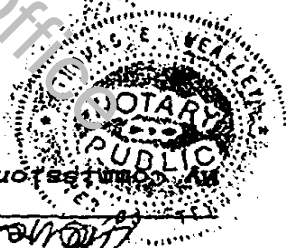
