MORTGAGE

THIS INDENTURE, made November 15th, 1990, by and between FIRST CHICAGO Bank of Ravenswood, not personally but as Trustee D/T/A dated March 20, 1987 A/K/A Trust No. 25-8412, (herein "Mortgagor"), and the NATIONAL SECURITY BANK OF CHICAGO, a mational banking association, therein "Mortgagoe"),

WITNESSETH:

THAT, WHEREAS Mortgagor is justly indebted to Mortgagee upon a Mortgage Note (sometimes referred to herein as "note") in the aggregate principal sum of TWO HUNDRED TEN THOUSAND AND NO/108 DOLLARS (\$210,000,00) (sometimes referred to as "Loan"), evidenced by one certain mortgage note of Mortgagor of even date herewith, made payable to the order of the NATIONAL SECURITY BANK OF CHICAGO and delivered to Mortgagee, in and by which said note Mortgagor promises to pay the principal sum of \$210,000.00 and interest of the rates as provided in said note; with a final payment of the balance due on the 9th day of November, 1995, and all of said principal and interest are made payable at such place as the holders of the note may, from time to time, in writing appoint, and is absence of such appointment, then at the office of the NATIONAL SECURITY BANK OF CHICAGO, 1030 W. TO HAVE AND TO HOLD the premises unto the said Mortgagee, its successors and assigns, forever, for the purposes and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

MAINTENANCE, REPAIR AND RESTORATION OF IMPROVEMENTS, PAYMENT OF PRIOR LIENS, ETC.

1. Mortgagor shall (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (b) keep said premises in good condition and repair, without waste, and free from mechanics' liens or other liens or claims for lien not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Mortgaged; (d) complete within a reasonable time any building or buildings row or at any time in process of erection upon said ordinances, or restrictions of record with respect to the premises and the use thereof, (f) make no material alterations in said premises except as required by law or municipal ordinance; (g) suffer or perait no change in the general nature of the occupancy of the premises, without Mortgagee written consont; (h) initiate or nequiesce in no zoning reclassification, without Mortgagee's written rowent; (if pay each item of indebtedness secured by this mortgage when due according to the terms hereof or of the note.

PAYMENT OF TAXES

2. Mortgagor shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor. To prevent default hereunder Mortgagor shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagor may desire to contest.

INSURANCE

3. Mortgagor shall keep all buildings est improvements now or hereafter situated on said promises insured against loss or damage by fire and such other hazards as may reasonably be required by Mortgagee. Mortgagor shall also provide liability insurance with such limits for personal injury and death and property damage as Mortgagee may reasonably require. All policies of insurance to be furnished herounder shall be in forms, from companies and in amounts reasonably satisfectory to Mortgagee, with mortgagee clauses attached to all policies in favor of and in form satisfactory to Mortgagee, including a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without ten (10) days prior written notice to Mortgagee. Mortgagor shall deliver all notices, including additional and renewal policies to Mortgagee, and, in the case of insurance about to expire, shall deliver respective dates of expiration.

In addition, Mortgagee shall have the right, in its sole discretion, to require the establishment of an escrow at Mortgagee for the payment of all items listed in this paragraph and paragraph 2, above.

INSURATION

4. In case of loss, Mortgagee for after entry of decree foreclosure, purchaser at the sale, or the decree creditor. οť the case may be) is hereby nuthorized either (a) to settle adjust any claim under such insurance policies without consent of Mortgagor, or (b) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss. either case Mortgagee is authorized to collect and receipt any such insurance money. If the insurers do not deny liability as to the insureds, such proceeds, after deducting therefrom expenses incurred in the collection thereof, shall be used reimburse Mortgagor for the cost of rebuilding or restoration buildings and improvements on said premises. In all other cases, such insurance proceeds may, at the option of Mortgagee, either be applied in reduction of the indebtedness secured hereby. whether due or not, or be held by Mortgagee and used to reimburse Mortgagor for the cost of the rebuilding or restoration of buildings or improvements on said premises. The buildings and improvements shall be so restored or rebuilt as to be of at least equal value and substantially the same character as prior to such damage or destruction. In the event hortgagor is entitled to reimbursement out of insurance proceeds, such proceeds shall be made available. From time to time, upon Mortgagee being furnished with satisfactory evidence of the estimated cost of completion thereof and with soch architect's certificates, waivers of lien, contractor's sworn statements and other evidence of cost and of payments as Mortgage ray reasonably require and approve, and if the estimated cost of the work exceeds ten percent (10%) of the original principal amount of the indebtedness secured hereby. with all plans and specifications for such rebuilding 0.11 restoration as Mortgagee may reasonable require and approve. No payment made prior to the foral completion of the work shall exceed ninety percent (90%) of the value of the work performed, from time to time, and at all times the undisbursed balance of said proceeds remaining in the hands of Mortgagee shall be at least sufficient to pay for the cost of the work free and clear of liens.

In case of loss after foreclosurs proceedings have been instituted, the proceeds of any such insurance policy or policies, if not applied as aforesaid in rebuilding or restoring the buildings or improvements, shall be used to pay the amount due in accordance with any decree of force osure that may be entered in any such proceedings, and the ballace, if any, shall be paid to the owner of the equity of redemption if he shall then be entitled to the same or as the court may direct. Mortgagee is hereby authorized, without the consent of Mortgagor, to assign any and all insurance policies to the purchaser at the sale, or to take such other steps as Myrtgagee may deem advisable, to cause the interest of such purchaser to be protected by any of the said insurance policies. 5. II, by the laws of the United States of America, or of any state having jurisdiction over Mortgagor, any tax is due or becomes due in respect of the issuance of the note hereby secured. Mortgagor covenants and agrees to pay such tax in the manner required by any such law. Mortgagor further covenants to hold harmless and agrees to indemnify Mortgagee, its successor or assigns, against any liability incurred by reason of the imposition of any tax on the issuance of the note secured hereby.

FUTURE ADVANCES

6. This Mortgare shall secure future advances, if any, made by Mortgagee under any subsequent agreement unless otherwise provided herein. All such advances made shall be secured hereby and shall have and be entitled to the same lien priority as that indebtedness first extended to Mortgager by Mortgagee under the Mortgage Note. All future advances shall be made under the terms of this noce or new notes and in no event shall be made after twenty years from the date hereof.

PREPAYMENT PYIVILEGE

7. At such time as Mortgagor is not in default either under the terms of the icte secured hereby or under the terms of this mortgage. Mortgagor shall have the privilege of making prepayments on the principal of said note (in addition to the required payments) in recordance with the terms and conditions, if any, set forth in said note.

OBSERVANCE OF LEASE ASSIGNMENT

8. In the event Mortgage, as additional security for the payment of the indebtedness described in and secured hereby, has sold, transferred and assigned, or may hereafter sell, transfer and assign, to Mortgage, its successors and assigns, any interest of Mortgagor as lessor in any lease or leases, Mortgagor expressly covenants and agrees that if Mortgagor, as lessor under such lease or leases assigned, shall fill to perform and fulfill any term, covenant, condition or provision in said lease or leases, or any of them, on its part to be performed or fulfilled, at the times and in the manner in said lease or leases provided, or if Mortgagor shall suffer or permit to occur any breach or default under the provisions of any assignment of any lease or leases of the premises given as additional security for the payment of the indebtedness secured hereby and such default shall continue for three (3) days, then and in any such event, such breach or default shall constitute a default hereunder.

EFFECT OF EXTENSIONS OF TIME.

9. If the payment of said indebtedness or any part thereof be extended or varied or if any part of the security be released, all persons now or at any time hereafter liable therefor or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by Mortgagee, notwithstanding such extension, variation or release.

EFFECT OF CHANGES IN LAWS REGARDING TAXATION

10. In the event of the enactment after this date of any law of the state in which the premises are located deducting from the value of land for the purpose of taxation any lien thereon, or imposing upon Mortgagee the payment of the whole or any part of

charges or liens herein required to the three or an estimate or the paid by Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the mortgagee's interest in the property, or the manner of collection of taxes, so as to affect this mortgage or the debt secured the holder thereof, then, and in any such event, hereby or Mortgagor, upon demand by Mortgager, shall pay such taxes or assessments, or reimburse Mortgagee therefor; provided, however, that if in the opinion of counsel for Mortgagee (a) it might be unlawful to require Mortgagor to make such payment or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, Mortgagee may elect, by notice in writing given Mortgagor, to declare all of the indebtedness secured hereby to be and become due and payable sixty (60) days from the giving OF such notice. Motwithstanding anything to the contrary contained herein, Mortgagor shall not be liable for any federal, state or local income, excess profit, franchise or capital stock taxes Mortgagee

MORTGAGEE'S PERFORMANCE OF DEFAULTED ACTS

II. In case of default therein, Mortgagee may, but need not, make any paymen or perform any act herein required of Mortgagor in any form and manuer deemed expedient, and may, but need not, make full or parcial payments of principal or interest on prior encumbrances, if vey, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therevith, including attorneys' fees, and any other moneys advanced by Mortgagee to protect the mortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at a rate which is five percent (5%) in excess of the mortgage rate. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor.

MORTGAGEE'S RELIANCE ON TAX BILLS, ETC.

12. Mortgagee in making payment hereby authorized: (a) relating to taxes and assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof; or (b) for the purchase, discharge, compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.

ACCELERATION OF INDEBTEDNESS IN CASE OF DEFAULT

13. If (a) default be made in the due and punctual payment of said notes, or any installment due in accordance with the terms thereof, either of principal or interest and such default shall not be cured within the earlier of ten (10) days following the delivery of notice thereof to Mortgagor or as otherwise provided in said notes; or (b) Mortgagor shall file a petition in voluntary bankruptcy or under Chapter 7, Chapter 11, or Chapter 13 of the Federal Bankruptcy Code or any similar law, state or federal, whether now or hereafter existing, or an answer admitting insolvency or inability to pay its debts within ten (10) days; or (c) Mortgagor shall fail to obtain a vacation or

Each remedy provided in this Morigage is distinct and cumulative to all other rights or remedies under this Morigage or afforded by taw or equity, and may be exercised concurrently, independently, or successively, in any order whatsoever. Morigage's forebearance to exercise any remedy hereunder shall not be deemed and shall not constitute a waiver of any right or remedy hereunder.

APPOINTMENT OF RECEIVER

17, bpan, or at any time after the filing of a complaint foreclose this mortgage, the court in which such complaint is filed may arount a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the belveney or insolvency of Mortgagor at the time of application for ruch receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestand or not and Mortgagee herounder or any holder of the note may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the perdency of such foreclosure suit and, in case of a sale and a deliciency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagor, except for the intervention of such receive, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said poriod. during the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of; (a) the indebtedness secured hereby, or by any decree foreclosing this mortgage, or any tax, special assessment or other lien which my be or become superior to the lien hereof or of such decree provided such application is made prior to foreclosure sale; (b) the deficiency in case of sale and deficiency.

ASSIGNMENT OF RENTS AND LEASES

Mortgagor does hereby sell, assign and transfer unto Mortgagee all the rents, issues and profits now due and which may hereafter become due under or by virtue of any lease insofar as it tertains to the premises or any part thereof, whether written or verbal, or any letting of, or of any agreement for the use or occupancy of the premises or any part thereof, which may have been heretofore or may be hereafter made or agreed to or which may be made or agreed to by Mortgagee under the powers herein granted, it being the intention hereby to establish an absolute transfer and assignment of all of such leases and agreements, and all the avails thereunder, unto Mortgagee, and Mortgagor does hereby appoint irrevocably Mortgagee its true and lawful attorney in its name and stead (with or without taking possession of the premises as provided in paragraph 19 hereof) to rent, lease or let all or any portion of said premises to any party or parties at such rental and upon such terms a Mortgagee shall, in its discretion, determine, and to collect all of said avails, rents, issues and

profits arising from or accruing at any time bereafter, and all now due or that may be reafter become due under each and every of the leases and agreements, written or verbal, or other tenancy existing, or which may be reafter exist on said premises, with the same rights and powers and subject to the same immunities, exponention of liability and rights of recourse and indemnity as Mortgagee would have upon taking possession pursuant to the provisions of paragraph 19 bereof.

 - (a) to the payment of the operating expenses of said property, including cost of management and leasing thereof (which shall include reasonable compensation to mortgage and its agent or agents, i management be delegated to an agent or agents, and shall elso include lease commissions and other compensation and expenses of scoking and procuring tenants and entering into leases); established claims for damages, if any, and premiums on insurance hereinabove authorized;
 - (b) to the payment of taxes and special assessments now due or which may be reafter become due on raid premises;
 - (c) to the payment of all repairs, decorating, renewals, replacements, alterations, additions, betterments, and improvements of said premises, and of placing said property in such condition as will, in the judgment of Mortgagee, make it readily rentable;
 - (d) to the payment of any indebtedness secured hereby or any deficiency which may result from any foreclosure sale.

MORTGAGEE'S RIGHT OF INSPECTION

21. Mortgagoe shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.

LATE CHARGE

22. In the event Mortgagee shall, from time to time, accept payment of any installment required on the note and under this mortgage which is more than fifteen (15) days in arrears without exacting payment of interest at the higher rate payable after

maturity. Mortgacee may, at its option, in freq of such higher rate of interest, rollect a "late charge" not to exceed live cents (\$.00) for each one dollar (\$1.00) of each such delinquent installment payment to cover the extra expense involved in handling delinquent payments; provided, however, that nothing in this paragraph contained shall authorize Mortgagee to collect or demand any payment which would result in the imposition of interest in excess of the maximum amount allowed by law.

CONDEMNATION

23. Mortgagor hereby assigns, transfers and sets over unto Mortgagee the entire proceeds of any award or any claim for damages for any of the mortgaged property taken or damaged under the power of eminent domain or by condemnation. Mortgagee may elect to apply the proceeds of the award upon or in reduction O. the indebtedness secured hereby, whether due or not, or require indebtedness secured hereby, whether due or not, or - to require Mortgagor to restore or rebuild, in which the proceeds shall be held by Mortgagee and used to reimburse Mortgagor for the cost of the rebuilding or restoring the buildings or approvements on said premises, in accordance with plans and specifications to be submitted to and approved by Mortgagee. If hartgagor is obligated to restore or replace the damaged or destroyed buildings or improvements under the terms of any lease or leases which are or may be prior to the lien of this mortgage and if such taking does not result in cancellation or termination of such levee, the award shall be used to reimburse Mortgagor for the cost of the rebuilding or restoring of buildings or improvement, on said premises, provided Mortgagor is not then in default under this mortgage. In the event Mortgagor is required or authorized either by Mortgagee's election as aforesaid, or by virtue of any such lease, to rebuild or restore, the proceeds of the award shal, be paid out in the same manner as is provided in paragraph. I hereof for the payment of insurance proceeds toward the cost of rebuilding or restoration. If the amount of such award is insufficient to cover the cost of rebuilding or restoration, Mortgarer shall pay such cost in excess of the award, before being extitled to reimbursement out of the award. of the award. Any surptus which may remain out of said award after payment of such cost of rebuilding or restoration shall, at the option of Mortgagee, be applied on account of the be paid to any other party indebtedness secured hereby or entitled thereto.

RELEASE UPON PAYMENT AND DISCHARGE OF MORTGAGOR 5 OBLIGATIONS

24. Mortgagee shall release this mortgage and the lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby and payment of a reasonably fee to Mortgagee for the execution of such release.

GIVING OF NOTICE

25. Any notice which either party hereto may desire () be required to give to the other party shall be in writing and the mailing thereof by certified mail addressed to Mortgagor at the mortgaged premises (designated by street address) or to the Mortgagee at its place of business or at such other place as any party hereto may by notice in writing designate as a place for service of notice, shall constitute service of notice hereunder.

WAIVER OF STATUTORY RIGHTS

26. Mortgagor shall not and will not apply for or availitself of any appraisoment, valuation, stay, extension or exemption laws, or any so-called "moratorium laws", now existing

or hereafter enacted, in order to prevent or hinder the enforcement of foreclosure of this mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the property and estates comprising the mortgaged property marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the mortgaged property sold as an entirety. Mortgagor hereby waives all rights of homestead exemption in the premises and any and all rights of redemption from sale under any order of decree of foreclosure of this mortgage on its behalf and on behalf of each and every person, except decree or judgment creditors of Mortgagor, acquiring any interest in or title to the premises subsequent to the date of this mortgage.

FURNISHING OF FINANCIAL STATEMENTS TO MORTGAGEE

27. Mortgagor covenants and agrees to furnish to Mortgagee such finencial statements as Mortgagee may reasonably require.

BINDING ON SUCCESSORS AND ASSIGNS

28. This hortgage and all provisions hereof, shall extend to and be binding upon Mortgagor and all persons claiming under or through Mortgagor, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the note or this mortgage. The word "Mortgagee" when used herein shall include the successors and assigns of mortgagee named herein, and the holder or holders, from time to time, of the note secured hereby.

LESSEE ATTORNMENT

29. In the event of the enforcement by Mortgagee of the remedies provided for by the law or by this Mortgage, the lessee under each lease of all or any part of the Premises made after the date of recording this Mortgage if any, shall, at the option of the Mortgagee, attorn to any person succeeding to the interest of Mortgagor, as a result of such enforcement and shall recognize such successor in interest as landlord under such lease without change in the terms or other provisions thereof, provided, however, that the said successor in interest shall not be bound by any payment of rent or additional rent for more than one month in advance or any amendment or modification to any lease made without the prior consent of Mortgagee or said successor in interest, shall execute and deliver an instrument or instruments confirming such attornment, and Mortgagor shall cause each such lease of all or any part of the Premises to contain a covenant on the lessee's part evidencing its agreement to such attornments.

TRANSFER OF PROPERTY OR INTEREST IN MORTGAGOR; ASSUMPTION

30. On sale or transfer of (i) all or any part of the premises, or any interest therein, or (ii) any beneficial interest in any land trust which may hereafter acquire title to the premises, to any person or entity, Mortgagee may, at its option, declare all sums secured by this Mortgage to be immediately due and payable, and Mortgagee may invoke any other remedies provided by this Mortgage, law or equity. This option shall not apply when the Mortgagee prior to the transfer or sale consents in writing to such transfer or sale subject to whatever terms the Mortgagee may require, including, an increase in the rate of interest payable under the note secured hereby.

Notwithstanding anything herein or in the note to the contrary, nothing herein or therein shall be deemed to prohibit transfers of interest in the Premises made in the ordinary course of business, subject to any limitations of the Mortgage.

RESTRICTION ON SECONDARY FINANCING

31. Mortgagor covenants and agrees that it will not, without the prior written consent of Mortgagee, which shall not be unreasonably withheld, further mortgage, grant a deed of trust, pledge or otherwise dispose of or further encumber, whether by operation of law or otherwise, any or all of its interest in the premises and any such mortgage, deed of trust, pledge or encumbrance made without the Mortgagee's prior written consent shall be null and void and the making thereof shall constitute a default under this Mortgage.

CAPTIONS

32. The captions and headings of various paragraphs of this mortgage are for convenience only and are not to be construed defining or limiting, in any way, the scope or intent of the provisions herecf.

EXCULPATORY CLAUSE

33. This Mortgage is executed by Trust, not personally, but as Trustee as aforesaid in the exercise of the power authority conferred upon and vested in it as such Trustee (and said Trustee hereby warrants that it possesses full power and authority to execute this instrument), and it is expressly understood and agreed that nothing herein or in said note contained shall be construed as creating any liability on said Trustee, personally to pay the note or any interest that may accrue thereon, or any indebtadness accruing hereunder, or to perform any convenant, either express or implied herein contained, all such liability, if any, being expressly waived by Mortgagee and by every person not or hereafter claiming any right or security hereunder, and that so far as said Trustee, any person interested beneficially or otherwise in the Premises, and said Trustee, personally are concerned, in case of default in the payment of said note, or of any installment of principal or interest, the remedies of the legal holder or holders of said note and the owner or owners of any indebtedness accruing hereunder shall be any, or all of (a) enforcement of the lien hereby created, in the manner herein or in sail note provided, (b) action against any other security given to secure the payment of said note or action to enforce the personal liability of any guarantor.
