
AFFIDAVIT OF COMPLIANCE WITH STATUTE REGARDING

1. That he is the Village Attorney for the Village of Orland Park, Cook County, Illinois, an Illinois Municipal Corporation.

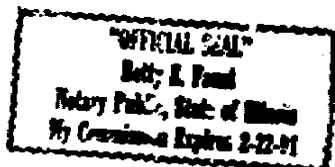

That at the regular meeting of the Board of Trustees of the Village of Orland Park held on October 1, 1990, an Ordinance, being Ordinance No. 1054, entitled, "AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN REAL ESTATE TO THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS (HADBIX)" was enacted, which Ordinance provided for the annexation to the Village of Orland Park of the real estate described in Exhibit A attached hereto and made a part hereof.

That more than ten (10) days prior to the enactment of said Ordinance, to-wit: on or about the 1st day of September, 1990, your affiant, on behalf of the Board of Trustees of the Village of Orland Park, searched to determine whether the above described real estate included any Township roads. No Township roads are included with the said real estate. Further, the Village of Orland Park does not provide fire protection service. Therefore, no notice was given to the Trustees of the Orland Fire Protection District, the Trustees of Orland Township, Illinois, or the Township Commissioner of Highways of Orland Township, Illinois, of the proposed Annexation of the above described real estate.
