whereas, to secure payment of the Amended Note, Mortgagor executed a modification of mortgage in favor of Mortgagee dated July 30, 1990 of the Premises, which mortgage was recorded in the office of the Recorder of Deeds of Cook County as Document No. 90444887 (the "Amended Mortgage"); and

WHEREAS, Jack Weiner also executed a note dated March 27, 1990 for the principal sum of Two Hundred Thousand Dollars (\$200,000.00) plus interest in favor of Mortgagor which note is currently due and payable; and

- 3. Inconsistent Terms. All of the terms of the Amended Mortgage are incorporated by reference herein; and in all respects the terms of the Amended Mortgage not inconsistent with the terms set forth herein shall remain in full force and effect.
