result in lower payments COVENANTS. Borrower and Lender covenant and agree as follows

1 PAYMENT OF PRINCIPAL AND INTEREST. Borrower shall promptly pay when due without setoff, or deduction, the principal of and interest on the debt evidenced by the Note, together with any late charges and other charges imposed under the Note

2. APPLICATION OF PAYMENTS. All payments received by Lender under the Note and this Mortgage shall be applied by Lender first in payment of amounts payable to Lender by Horrower under paragraphs 6 and 28 of this Mortgage, then to interest due on the Note, then to charges payable under the Agreement, and then to the principal of the Note

3. PRIOR MORTGAGES AND DEEDS OF TRUST, CHARGES, LIENS, Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a hen which has or appears to have any priority over this Mortgage including Borrower's covenants to make any payments when due. 13. NOTICES. Any notice to Borrower provided for in this Mortgage shall be given by hand delivering it or by availing such notice by registered or certified mail unless applicable law requires use of another method. The Notice shall be directed to the Property Address or any other address Borrower designates by notice to Lender. Any notice to Lender shall be given by first class mail to Lender's address stated herein (Attn: Consumer Lending Department) or any other address Lender designates by notice to Borrower. 14. GOVERNING LAW: SEVERABILITY. This Mortgage shall be governed by Federal law and the law of Illinois. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provisions. 16. REMEDIES CUMULATIVE. a. Notice. 18. TRANSFER OF THE PROPERTY. As additional specific protection, notwithstanding any other term of this Mortgage, Lender, without declaring or asserting an Event of Default or invoking any of its remedies pertaining to Events of Default, may, immediately and without notice, refuse to make additional extensions of credit under the Line, or reduce your Maximum Credit Limit under the Line upon the occurrence of any event enumerated in paragraph 17 of this Mortgage. Notice of any such refusal or reduction shall be given in accordance with the provisions of paragraph 18 of this Mortgage. Refusal of additional credit extensions, or reduction of credit under the Line will not preclude Lender from subsequently exercising any right or remedy set forth herein or in any of the Credit Documents.
