1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal and interest indebtedness evidenced by the Note and late charges as provided in the Note.

2. Funds for Taxes and Insurance. 10. Borrower Not Released; Forbearance By Lender Not a Waiver. 13. Governing Low, Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located.
