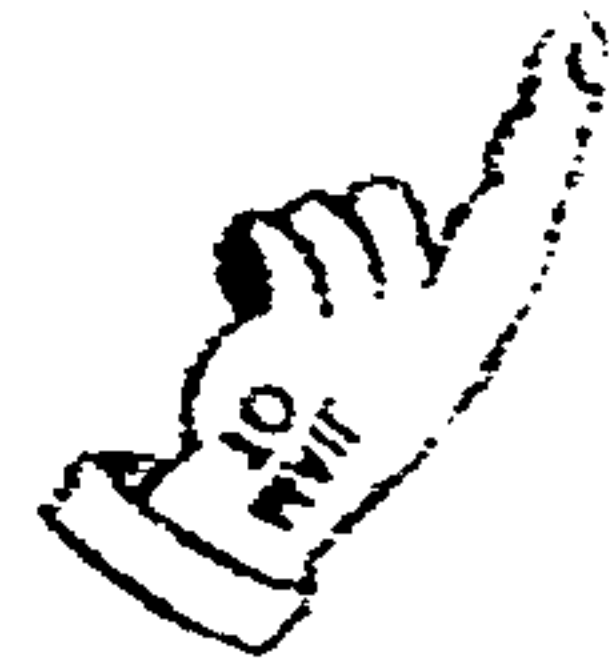

LEGAL DESCRIPTION

That part of the southeast quarter of Section 36, Township 42 North, Range 11 East of the Third Principal Meridian, lying East of the Center line of River Rd. and lying West of center thread of DesPlaines River, excepting therefrom the following two tracts of land described as follows:

Beginning at the point of intersection of the Central Rd. and River Rd., said point being in the South line of said Section and 961.8 ft. West of the Southeast corner of the Southeast quarter of said Section; thence Easterly along the South line of said section 930.0 ft.; thence Northerly 783.0 ft. at a 90 degrees angle to the last described course; thence Westerly 1133.5 ft. at a 90 degrees angle to the last described course to a point in the center line of River Rd.; thence Southeasterly along the center line of River Rd. to the point of beginning and also except: commencing at a point in the South line of the Southeast quarter of Section 36, Township 42, North, Range 12 East of the Third Principal Meridian, a distance of 31.80 ft. West of the Southeast corner of said section; thence north perpendicular to said South line of said Section 36, a distance of 783 ft. for a point of beginning; thence West perpendicular to the last described course, a distance of 1,120.06 ft. to the center line of River Rd. as paved; thence Northwesterly along the center line of River Rd. as paved, a distance of 100 ft.; thence Northeasterly perpendicular to the center line of River Rd. as paved, a distance of 920 ft.; thence Southeasterly a distance of 404.94 ft. to the point of beginning, all in Cook County, Illinois,

commonly described as approximately 43 acres located on the east of Des Plaines River Rd., West of the Des Plaines River and the Wheeling/Northfield Township line, South of the Cook County Forest Preserve District boundary and North of Central Rd., all in Wheeling Township.
