

EXHIBIT "A"

Legal Description

That part of Lot 1 in Westwind Court, being a Subdivision of part of the Northwest fractional quarter of Section 30, Township 36 North, Range 13, East of the Third Principal Meridian, described as follows: commencing at the Southwest corner of said Lot 1, thence due East along the South line of said Lot 1 for a distance of 8.50 feet to a point; thence due North for a distance of 71.89 feet to a point of beginning, said point lying on the Westerly extension of the center line of a party wall; thence South 89 degrees 54 minutes East along said center line of a party wall and the Easterly and Westerly extensions thereof for a distance of 74.00 (est to a point; thence due North for a distance of 29.28 feet co a point on the Easterly extension of the center line of a party wall; thence North 89 degrees 54 minutes West along said center line of a party wall and the Easterly and Westerly extensions thereof for a distance of 74.00 feet to a point; thence due South for a distance of 29.28 feet to the point of beginning, all in Cook County, Illinois.
