

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penelty, together with any costs that may accrue in addition thereto) shall be a few in tevor of the United States upon all property and rights to V

Sec. 6322, Period Of Lien.

United according to a specifically fixed by law, the lien inposed by section 5321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse

Sec. 6323. Validity and Priority Against

(a) Purchaser's Holders Of Security Interests, Mechanic's Llenors, And Judgment Lien Creditors. - The lien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(f) Place For Fliing Notice; Form.-

(1) Place For Filing . The notice referred to in subsection · belil ed lisha (a)

(A) Under State Laws

(i) "Real Property " in the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the filen is situated; and William

(i) Personal Property : in the case of personal property, whether tangible or intangible, in one office within the Sizes (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the flen is situated; or

(B) With Clerk OI District Court-In the office of the derk the United States district court for the judicial district in which the property subject to tien is situated, whenever the State has not by law designated one office which meets the requirements

of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbiain the office of the Recorder of Deeds of the District of Columbia, If the property subject to the ilen is situated in the District of Columbia.

(B) Personal Property - In the case of personal property, whether langible or intangible, at the residence of the taxpayer at the time the notice of lien is filed.

- (p) Refiling Of Notice. For purposes of this
- General Rule. -- Unless notice of tien is reflied in the manner prescribed in paragraph (2) during the required reliling period, such notice of lien shall be treated as filled on the date on which it is filed (in accordance with subsection (f)) after the expiration of such relifting period. $\mathbb{Q} \cap_{\mathcal{O}} \mathcal{O} \cap$
- (2) Place For Filing.—A notice of lien refilled dur-ing the regulard refilling period shall be effective only -

(A) (i) such notice of then is reflied in the office in which the prior notice of lien was filed; and

(ii) in the case of real property, the fact of refiling is entered and recorded in an index to the extent required by subsection (f) (4), and

Sec. 6325. Release Of Lien Or Discharge Of Property.

(a) Release Of Lien. - Subject to such regula-

tions as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become

legally unenforceable; or

(2) Bond Accepted-There is furnished to the Secretary and expled by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect therec, with a time prescribed by law (Including any extension a such time), and that is in accordance with such requirements relating in terms, conditions, and form of the bond and suraties thereun, us may be specified by such regulations.

(x) Disclosure of Certain Returns and Return information For Tax Administration Purposesia

(2) Disclosure of amount of outstanding tien, if a notice of lien has been filed pursuant to section 6323(f), the amount of the outstanding obligation secured by such tien may be disclosed to any person who furnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
