Borrower acknowledges that the Note allows for changes in the interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances thereunder and/or require repayment of the outstanding balance under the Note. Increases in the interest rate may result in higher payments. Decreases in the interest rate may result in lower payments.

COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest. Borrower shall promptly pay, when due, without setoff, or deduction, the principal of and interest on the debt evidenced by the Note, together with any late charges and other charges imposed under the Note.
- 2. Application of Payments. All payments received by Lender under the Note and this Mortgage shall be applied by Lender first in payment of amounts payable to Lender by Borrower under paragraphs 6 and 28 of this Mortgage, then to interest due on the Note, then to charges payable under the Agreement, and then to the principal of the Note.
- 3. Prior Mortgages and Deeds of Trust: Charges: Liens. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due.

 Borrower shall pox all taxes, assessments, charges, lines and impositions attributable to the Property which may attain priority over this Mortgage, and leasehold payments or ground rents, it any. Borrower shall promptly furnish to Lender all notice of aumounts to be paid under this paragraph. The Borrower shall make these payments directly, and promptly furnish to Lender receipts evidencing the payments.

Borrower shall prompaly discharge any lien which has priority over this Mortgage other than the prior mortgage described above, unless Borrower. (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender; (b) contests, in good taith, the lien by or detends against enforcement of the lien in legal proceedings, which, is too Lender's opinion, operate to prevent the enforcement of the lien or forfeiture of any part of the Property, or (c) secures from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this Mortgage. It Lender determines that any part of the Property is subject to a lien which may attain priority over this Mortgage. Lender may give Borrower a notice identifying the lien. Borrower shall satisfy the lien, or take one or more of the actions set forth in this Mortgage, within 10 days of the giving of notice.

4. Hazard Insurance. Borrower shall keep the opprovements now existing or hereafter erected on the Property insured against loss by tire, hazards included within the term "extended coverage" and such other hazards as Lender may require provided that Lender shall not require that the amount of such coverage exceed that amount of coverage required to pay the sums secured by this Mortgage and all other mortgages and deeds of frust with respect to the Property, but, in no event, shall amounts be less than the amount necessary to satisfy the coinsurance requirements contained in the insurance policy. The insurance eatrier providing the insurance shall be chosen by Borrower, subject to approval by Lender, which shall not be unreasonably withfield. All premiums on insurance policies shall be paid by Borrower when due

All insurance policies and renewals shall be in form acceptable to Lender and shall include a standard mortgage clause in tayor of and in form acceptable to Lender. Lender shall be the right to hold the policies and renewals subject to the terms of any mortgage, deed of trust or other security a regiment with a lien which has, or appears to have, any priority over this Mortgage. If Lender requires, Borrower shall gromptly furnish to Lender all renewal notices and all receipts of paid premiums. Borrower shall give prompt notice to the insurance carrier and to Lender of any loss or damage to the Property. Lender may make proof of loss if not roade promptly by Borrower. All policies shall provide further that the Lender shall receive 10 days notice prior to carcellation.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damages, if the restoration or repair is economically feasible and Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage, whether or not then due, with any excess paid to Borrower. If Borrower abandons the Property, or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender is irrevocably authorized to settle the claim and to collect and apply the insurance proceeds at the Lender's sole option either to restoration or repair of the Property or to the sums secured by this Mortgage. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due. The 30 day period will begin when the Notice is given

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the monthly installments referred to in the Mortgage or change the amount of such installments. If the Property is acquired by Lender, all right, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to the sale or acquisition shall pass to Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

- 5. Preservation and Maintenance of Property: Leasennias, Condominiams; Planned Unit Developments. - 23. Incorporation of Terms. All of the terms, conditions and provisions of the Agreement and Note are by this reference incorporated herein as if set forth in full. Any Event of Default under the Note or the Agreement shall constitute an Event of Default hereunder, without further notice to Borrower
 - 24. Time of Essence. Time is of the essence in this Mortgage, and the Note and Agreement
- 25. Actual Knowledge. For purposes of this Mortgage and each of the other Credit Documents, Lender will not be deemed to have received actual knowledge of information required to be conveyed to Lender in writing by Borrower until the date of actual receipt of such information at Lender's address, as provided herein, (or such other address specified by Lender to Borrower). Such date shall be conclusively determined by reference to the return receipt in possession of Borrower. If such return receipt is not available, such date shall be conclusively determined by reference to the "Received" date stamped on such written notice by Lender of Lender's agent.
