#### AMENDMENT TO NOTE AND MORTGAGE

This AMENDMENT made as of this // day of December, 1990 by and among AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO not personally, but as Trustee under Trust Agreement dated April 2, 1985, and known as Trust No. 63964 ("Trustee"), and Richard A. NOW, THEREFORE, in consideration of the foregoing and of the covenants and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Borrower and Lender hereby agree as follows:

  - (b) All references in the Note to the "Mortgage" shall be deemed to refer to the Mortgage as amended hereby.
  - (c) All references in the Note to the "Note" shall be deemed to refer to the Note as amended herepy.
- 2. The Mortgage is hereby amended as follows:
  - (a) The amount of the Loan in the seventh line of paragraph 1 on page 1 is hereby deleted and the amount of \$775,000.00 is hereby substituted therefor.
  - (b) All references in the Mortgage to the "Note" shall be deemed to refer to the Note as amended hereby.
  - (c) All references in the Mortgage to the "Mortgage" shall be deemed to refer to the Mortgage as amended hereby.
- 3. Except as amended hereby or pursuant hereto, the Note, the Mortgage, and all other documents executed in connection with the Loan shall be and remain unchanged and in full force and effect in accordance with their respective terms and are hereby ratified and confirmed.
