It is undercrost that this postponement and subordination shall be equally effective in the event of any administration of the property and/or affairs of the Debtor arious from bankruptcy, receivership, liquidation, assignment, or other like proceedings.

This agreement shall continue in full force and effect until receipt by the Bank from the undersigned of written notice of cancellation endorsed hereon by the undersigned. Ho one or different notice of cancellation shall be of any effect. Notwithstanding notice of cancellation given by endorsement hereon as herein provided, this agreement shall nevertheless thereafter remain in full force and effect with respect to all indebtedness and/or liabilities of the Debtor to the Bank due and owing at the time of said receipt and endorsement, together with all interest, charges and top insest then due or thereafter payable upon or in connection with such existing injebtedness or liabilities, and the Bank may thereafter continue to grant to the Biblor renewals and/or extensions of time, and may otherwise proceed in its sole direction in the enforcement of such indebtedness and/or liabilities existing at the time of receipt and endorsement of notice of cancellation until all of sald sums shall have been paid in full, without in any manner impairing, lessening, or invalidating the force and effect of this agreement.

This agreement shall inure to the benefits of LaSALLE RANK NORTHBROOK, its successors and assigns, and shall be binding as to its terms on the heirs, personal representatives of puccessors and assigns of the undersigned.
