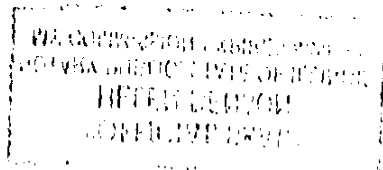
RELEASE OF TRUST DEED
