### QUITCLAIM DEED

Grantor, THE ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY, a Delaware corporation, whose address is 920 S. E. Quincy, Topeka, Kansas 66628, for and in consideration of the sum of TEN AND NO/100 DOLLARS and other good and valuable considerations, the receipt of which is hereby acknowledged, CONVEYS and QUITCLAIMS to CHICAGO TITLE AND TRUST COMPANY, a corporation of Illinois, whose address is 111 West Washington Street, Chicago, Illinois 60602, as Trustee under the provisions of a Trust Agreement dated the 28th date of October, 1988, known as Trust Number 1092281, Grantee, all its interests in and to the property legally described in Exhibit "A" attached hereto and made a part hereof (nereinafter "the Property").

RESERVING UNTO GRANTOR, its successors and assigns, a perpetual easement (the "Easement") for invess and egress purposes over, under, upon, through and across the Property as an easement appurtenant to all of the property now or hereafter owned by Grantor in Sections 21, 28, 29, 32 and 33, all in Township 38 North, Range 12 East of the Third Principal Meridian, including without limitation that portion thereof described in Exhibit "B" attached hereto and made a part hereof, provided, however, that the Easement shall terminate when any portion of the Property is redeveloped for use as a traffic interchange for U.S. Highway 294.
