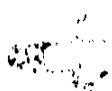

6. Mortgagee may proceed to foreclose this Mortgage by judicial proceedings according to the Statutes in such case provided, and any failure to exercise said option shall not constitute a waiver of the right to exercise the same at any other time.

b. Failure to Improve Premises

The failure of the Mortgagor to improve the Premises as set forth in the plans and specifications or in the General Contractor Statement previously provided to the Mortgagor, and to complete the same within one year from the date hereof shall be considered an event of default and the Mortgagee shall have the right to foreclose the Mortgage or institute proceedings on the Promissory Note securing the same.

c. Expense of Foreclosure Litigation

g. Rescission of or Failure to Exercise Option of Acceleration
