EXHIBIT A

LEGAL DESCRIPTION PARCEL 2

That part of Lot 11 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988 as Document No. 88 598 270 described as follows: Commencing at the Northeast corner of said Lot 11; thence South 53 degrees 20 minutes 00 seconds West along the Easterly line of said Lot 11 a distance of 110.17 feet for a place of beginning; thence continuing South 53 degrees 20 minutes 00 seconds West along the Easterly line of said Lot 11 a distance of 26.49 feet; thence North 13 degrees 24 minutes 46 seconds East 149.40 feet to a point on a curve, being the Northerly line of said Lot 11; thence Easterly along the arc of said curve, being the Northerly line of Lot 11, being concave to the South, having a radius of 170.00 feet, having a chord bearing of South 63 degrees, 14 minutes 52 seconds East for a distance of 17.48 feet; thence South 13 degrees 24 minutes 46 seconds West 125.05 feet to the Place of Beginning, said parcel of land herein described contains 0.054 acres, more or less, in Cook County, Illinois.
