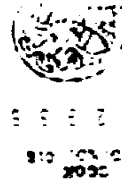

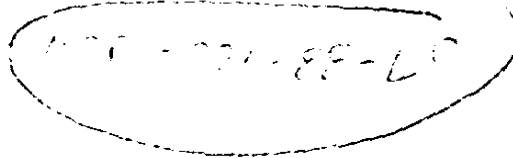
That part of Lot 19 in Washington Court, being a subdivision
