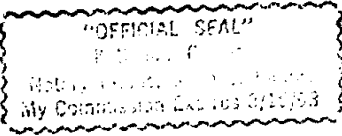

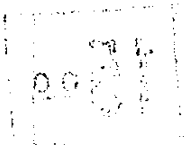

EXHIBIT A

LEGAL DESCRIPTION PARCEL B
