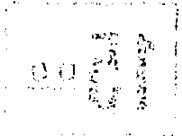

EXHIBIT A

LEGAL DESCRIPTION PARCEL 7

That part of Lot 15 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988 as Document No. 88 598 270 described as follows: Commencing at the most Westerly Southwest corner of said Lot 15; thence North 25 degrees 45 minutes 30 seconds West along the Westerly line of said Lot 15 a distance of 112.91 feet for a place of beginning; thence continuing North 25 degrees 45 minutes 30 seconds West along the Westerly line of said Lot 15 a distance of 17.00 feet; thence North 64 degrees 28 minutes 38 seconds East 25.21 feet; thence South 89 degrees 00 minutes 00 seconds East 32.46 feet to a point on the Easterly line of said Lot 15; thence Southerly along the arc of a curve, being the Easterly line of said Lot 15, being concave to the East, having a radius of 63.00 feet, having a chord bearing of South 03 degrees 37 minutes 53 seconds East for a distance of 10.25 feet; thence South 81 degrees 40 minutes 14 seconds West 23.70 feet; thence South 64 degrees 28 minutes 38 seconds West 87.73 feet to the Place of Beginning; said parcel of land herein described contains 0.042 acres, more or less, in Cook County, Illinois.
