- Any change of registered agent to st be by resolution adopted by the board of directors. This state ment must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
- The registered agent may report a change of the registered office of the corporation for which he for she is registered agent. When the agent reports such a change, this statement must be signed by مين . . . the registered agent.
