THIS INSTRUMENT WITNESSETH, That the Grantor, THE SISTERS OF SAINT CASIMIR OF CHICAGO, a corporation duly organized and existing under and by virtue of the laws of the State of Illinois, and duly authorized to transact business in the State of Illinois, for and in consideration of the sum of TEN DOLLARS (\$10.00), and pursuant to authority given by the Board of Directors of said corporation, CONVEYS and QUIT CLAIMS unto HOLY CROSS HOSPITAL, a corporation duly organized and existing under and by virtue of the laws of the State of Illinois, having its principal office in the City of Chicago, County of Cook and State of Illinois, all interest in the following described real estate, to-wit:

Blocks Five (5) and Six (6), except the East one hundred fifty (150) feet of Block Six (6) and except the West thirty-five (35) feet of the East one hundred eighty-five (185) feet of the South one hundred eighty (180) feet of Block Six (6), in Hirsh and Young's Subdivision of the North West Quarter (NW 1/4) of the South East Quarter (SE 1/4) of Section Twenty-four (24), Township Thirty-eight (38) North, Range Thirteen (13), East of the Third Principal Meridian;
