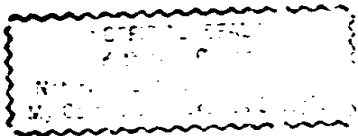

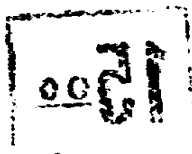

EXHIBIT A

LEGAL DESCRIPTION PARCEL 6

That part of Lot 19 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988 as Document No. 88 598 270 described as follows: Commencing at the Northwest corner of said Lot 19; thence North 88 degrees 16 minutes 50 seconds East along the North line of said Lot 19 a distance of 103.25 feet for a place of beginning; thence continuing North 88 degrees 16 minutes 50 seconds East along the North line of said Lot 19 a distance of 17.01 feet; thence South 0 degrees 16 minutes 00 seconds West 127.07 feet to a point on a curve, being the Southerly line of said Lot 19; thence Westerly along the arc of said curve, being the Southerly line of Lot 19, being concave to the South, having a radius of 55.00 feet, having a chord bearing of North 83 degrees 32 minutes 21 seconds West for a distance of 17.17 feet; thence North 0 degrees 16 minutes 00 seconds East 124.63 feet to the Place of Beginning; said parcel of land herein described contains 0.049 acres, more or less, in Cook County, Illinois.
