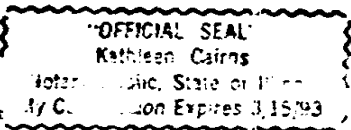

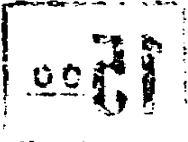

EXHIBIT A

LEGAL DESCRIPTION PARCEL 1

That part of Lot 15 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 30, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 27th, 1988 as Document No. 88 598 270 described as follows: Beginning at the most Westerly Southwest corner of said Lot 15; thence North 25 degrees 45 minutes 30 seconds West along the Westerly line of said Lot 15 a distance of 27.91 feet; thence North 64 degrees 28 minutes 38 seconds East 102.28 feet; thence North 23 degrees 19 minutes 16 seconds East 27.22 feet to a point on a curve, being the Easterly line of said Lot 15; thence Southeasterly along the arc of said curve, being the Easterly line of Lot 15, being concave to the Northeast, having a radius of 63.00 feet, having a chord bearing of South 71 degrees 01 minute 45 seconds East for a distance of 9.57 feet to the most Easterly corner of said Lot 15; thence South 14 degrees 37 minutes 15 seconds West along the Easterly line of said Lot 15 a distance of 69.34 feet to a bend point; thence South 58 degrees 27 minutes 51 seconds West along the Easterly line of said Lot 15 a distance of 65.77 feet to the most Southerly corner of said Lot 15; thence North 70 degrees 31 minutes 00 seconds West along the Southerly line of said Lot 15 a distance of 28.30 feet to the Place of Beginning; said parcel of land herein described contains 0.105 acres, more or less, in Cook County, Illinois.
