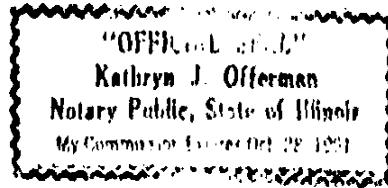

## LEGAL DESCRIPTION

That part of Lots 1 to 6 and 21 to 26, all inclusive in Block 6 in the Subdivision of Lots 1 and 2 of Block 8 in Sheffield's Addition to Chicago, Cook County, Illinois situated in the West half of the Southeast quarter of Section 32, Township 40 North, Range 14 East of the Third Principal Meridian.

Also Lots 4, 5, 6, 7, 8, 9 and that part of Lot 3 lying North and Northwesterly of a line described as follows:

Beginning at a point in the West line of Sheffield Avenue, 244.47 feet South of the intersection of said West line of Sheffield Avenue with the Southwesterly line of Clybourn Avenue, and running,

thence West at right angles to said West line of Sheffield Avenue, 81.58 feet more or less to its intersection with a line drawn parallel to and 164.47 feet Southeasterly of the Southeasterly line of Willow Street as now occupied,
