SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM FOR GREAT GLOBAL CONDOMINIUM

This Declaration made and entered into this 18711 day of Jan Ary, 1970, by CHICAGO TITLE & TRUST COMPANY, a corporation of Illinois, as Trustee under Trust Agreement dated August 28, 1983, and known as Trust No. 1084163 and not individually (the "Trustee");

WITNESSETH:

WHEREAS, by a Declaration of Condominium (the "Declaration") recorded in the office of the Recorder of Cook County, Illinois, as Document No. 88418678, the Trustee submitted certain real estate to the provisions of the Illinois Condominium Property Act (the "Act"); and


WHENZAS, a First Amendment to said Declaration of Condominium ("First Amendment") was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 89066753; and

WHEREAS che Declaration reserves to the Developer (as defined in the Declaration) the right to annex and add to the Parcel and Property (as defined in the Declaration) and thereby add to the condominium created by the Declaration all or any portion of the additional land (as lefined in the Declaration); and

WHEREAS, the Truste: at the direction of the Developer now desires to so annex and add to said Parcel and Property and submit to the provisions of the Act and the Declaration certain real estate (the "Additional Property"), described in Part II of Exhibit A attached hereto, which Additional Property is a portion of the said additional land;

NOW, THEREFORE, the Truster does hereby amend the Declaration as follows:

- 1. The Additional Property is hereby annexed to the Parcel and Property as defined in the Declaration, and is hereby submitted to the provisions of the Act as a part of the Condominium in accordance with and shall be deemed to be governed in all respects by, the terms and provisions of the Declaration.
- 2. Exhibit A of the Declaration is hereby arended by deleting said Exhibit A and substituting therefor Part 2 of the Exhibit A which is attached hereto.
- 3. Exhibit B of the Declaration is hereby amended by substituting therefor the Exhibit B which is attached hereto. The percentage of ownership in the common elements appurted to each unit is hereby shifted to the percentages set forth in the Exhibit B which is attached hereto.
- 4. Exhibit C of the Declaration is hereby amended by substituting therefor the Exhibit C which is attached hereto.
- 5. The additional common elements annexed by this instrument are hereby granted and conveyed to the grantees of all units, including the grantees of units heretofore conveyed, all as set forth in the Declaration.
- Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
